The last date for submission of bids in respect of above tender published in leading newspapers vide No. INF-KRY.3562/17 dated: 31-07-2017 was specified as **21st August 2017**, which was extended upto **Tuesday 5th September 2017 till 02:00 PM** under Rule 22 of SPP Rules 2010 through issuance of "**Corrigendum/Extension Notice**" hoisted on the website of SPPRA at SR. No. 34106 as well as Board of Revenue, Sindh.

2. However, due to ban on publication of Sindh Government's Advertisements by APNS on account of pending liabilities, the "**Extension/Corrigendum Notice**" could not be published in leading newspapers in compliance with Rule 17(1A) of SPP Rules 2010 and was only hoisted on the website of Procuring Agency at www.borsindh.gov.pk and SPPRA.

3. Hence, in order to ensure compliance of Rule 17(1A) of SPP Rules 2010 for wider competition in the bidding process in accordance with advice of SPPRA, the bid submission deadline is hereby further extended till **18th September 2017 till 2:00 PM**. The technical proposal against the submitted bids shall be opened at **2:30 PM on Monday 18th September 2017** by the Procurement Committee in the Committee Room of PMU ASR. Other terms and conditions shall remain unchanged.
