NO FURTHER EXTENSION NOTICE

TENDER TITLE: "DEVELOPMENT AND DEPLOYMENT OF E-REGISTRATION SYSTEM WITH SUPPLY, INSTALLATION AND COMMISSIONING OF I.C.T INFRASTRUCTURE ALONG WITH RENOVATION OF DEDICATED SITES OF BOARD OF REVENUE SINDH" FOR THE PROJECT OF AUTOMATION OF STAMPS & REGISTRATION, 21 DISTRICTS EXTENSION TO ALL DISTRICTS IN SINDH

The last date for submission of bids in respect of above tender published in leading newspapers vide No. INF-KRY.3562/17 dated: 31-07-2017 was specified as **21st August 2017**, which was extended upto **Tuesday 5th September 2017 till 02:00 PM** under Rule 22 of SPP Rules 2010 through issuance of "**Corrigendum/Extension Notice**" was hoisted on the website of SPPRA at SR. No. 34106 and on the website of BOR Sindh at www.borsindh.gov.pk.

2. The bid submission deadline was again extended upto 18th September 2017 due to non-publication of the notice in leading newspapers by Information Department, Govt. of Sindh and a copy of the same was hoisted on the website of BOR www.borsindh.gov.pk and forwarded to SPPRA. The last date was once again extended upto **Friday 29th September 2017 till 2:00 PM** in compliance with Rule 17(1A) of SPP Rules 2010.

3. However, due to continued ban on advertisement upto 29th September 2017, the advertisement could not be published in leading newspapers and thus compliance of rule 17(1) of SPP Rules 2010 could not be ensured. Hence the tendering process was cancelled.

4. The fresh procurement process has now been undertaken and advertised vide INF KRY NO. 3926/17, dated: 27-09-2017 and bidding documents are uploaded on the website of SPPRA at SR. No. 34585 and BOR, i.e. www.borsindh.gov.pk wherein last date of submission of bids is specified as **13th October 2017** and it is notified for information of all interested bidders that no further extension request in respect of the fresh procurement process will be considered as sufficient time in for the bidding process has already been allowed by the procuring agency in the instant procurement.
